In accordance with City Ordinance, (Sec. 66-78), parking stickers shall be issued **ONLY** to Deerfield Beach residents. A resident is defined as someone who resides within Deerfield Beach city limits.

Deerfield Beach code stipulates; no person shall be issued a City parking permit unless the following original documents (or facsimile thereof) are provided:

- A current vehicle registration in the name of the applicant or evidence that the applicant has a lease on the vehicle for which the sticker will be affixed to.
- A current and valid driver's license.
- A current utility bill reflecting a Deerfield Beach address or a valid Florida Voter Registration Card reflecting a Deerfield Beach address.

I HEREBY ACKNOWLEDGE AND ACCEPT THE FOLLOWING: THE PERMIT (STICKER) IS **NOT TRANSFERABLE**. IF I PURCHASE A NEW VEHICLE I SHALL REMOVE THE STICKER AND RETURN IT WITH THE NEW REGISTRATION OR TITLE FOR A REPLACEMENT STICKER AT NO CHARGE TO ME. HOWEVER, IF I FAIL TO BRING IN THE OLD STICKER I WILL BE CHARGED A REPLACEMENT FEE OF **TEN (\$10) DOLLARS**. I UNDERSTAND THAT I AM ALLOWED **ONLY ONE (1)** REPLACEMENT STICKER PER CALENDER YEAR.

I certify that I am a resident of Deerfield Beach and that I am the owner/lessee of the vehicle listed above to which the parking permit has been assigned to. I acknowledge and accept that providing false information on this application or misusing the parking sticker (*placing it on a different vehicle*) is a violation of City of Deerfield Beach Ordinance Sec. 66-82, and punishable by a fine not to exceed \$500 or a prison term not to exceed 60 days (Sec. 1-15 (d)) and cancellation of my permit parking privileges.
