



## 2022 Application for Martin Luther King, Jr. Birthday Celebration Parade

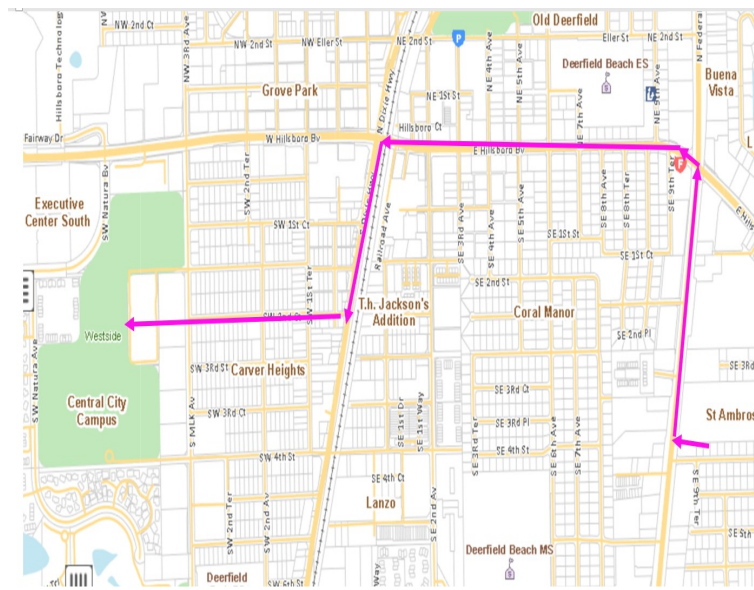

The Martin Luther King, Jr. Birthday Celebration is a thrilling two day event starting with a family fun Unity Concert Day on January 15<sup>th</sup> and ending with an exciting parade and program celebrating the birth of Martin Luther King, Jr. on Monday, January 17th.

The parade will line up at St. Ambrose (380 Federal Hwy); we ask that you check in at 8:30 AM. The parade will begin at 10:00 AM and will go north on US-1 for 0.4 miles and turn left onto E Hillsboro Blvd for 1.1 miles then turn left onto SW 3rd Ave/SW Martin Luther King, Jr. Ave for 0.2 miles, head west on SW 2nd street, ending at the Oveta McKeithen Recreational Complex (445 SW 2nd Street).

Following the parade, there will be an awards ceremony at the Oveta McKeithen Recreational Complex. Trophies will be given to the winner in each of the below listed categories. Be sure when filling out the application, that you list the category for which you wish to be considered. Judges will be located on the stage in the front parking lot of the Food Bazaar Shopping Center (202 W Hillsboro Blvd.) located on Hillsboro Blvd. Please note, it is important for you to provide the names of those that you would like acknowledged by the emcee together with any other information about your entry, should you be chosen as a winner.
