### **Notes:**

1. Violation: Illegal removal of trees may cost up to \$5000.00 per tree, which does not include tree replacements and/or mitigation of \$200.00 per 3" of tree diameter.
2. All trees are to be replaced **within 30 days of signed permit** enforcement action will be taken.
3. Relocated trees must be replaced. If they die within 1 year, by FL#1 Quality or better.
4. All tree removal or relocation to be done by a certified arborist or Broward County licensed tree specialist.
5. All replacement trees are to comply with the City of Deerfield Beach LDC code.
6. Stump and roots to be ground to minimum 6" below grade.
